<u>ORDER</u>

1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Adv. Enam Yangfo, Bazarline Seppa, PO/PS Seppa, East Kameng District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-DPDO, Govt. of A.P., O/O the District Panchayat Development Officer, Old DC Administrative Building Seppa, East Kameng District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 25/09/2024 regarding transferred / Distribution of Performance Grants (SoR) funds of Rs. 8, 48, 70, 000 of 2022-23 under XV FC in GPs & ZPs Accounts.

2). The 3rd hearing was held on 8th July' 2025. The PIO-cum-DPDO, Govt. of A.P., O/O the District Panchayat Development Officer, Old DC Administrative Building Seppa, East Kameng District, Arunachal Pradesh was represented by Shri Achung Gyadi, APIO. The Appellant Adv. Enam Yangfo appeared before the court through video conferencing.

3). The APIO submitted that information had been prepared according to the Commission's direction given on the 2^{nd} hearing held on 3^{rd} June'2025 but the Appellant did not turned up to collect information, so the same had been brought to the court. The APIO had informed that he had telephonic conversation with the Appellant and he will be sending the information through postal service at the Appellant's address.

4). The Commission directed the APIO to furnish information directly by hand, the Appellant was also asked to collect the information directly from the office of the PIO within 15 (fifteen) days from the date of issue of this order and intimate to the Commission of his satisfaction or dissatisfaction. On the basis of input from the Appellant, the next date of hearing would be fixed or the case will be disposed of. It was also cautioned that failing to intimate within above stipulated time the case shall be disposed of.
