**Information sought :**

The appellant file an RTI Application dated 08/06/2024 seeking Details regarding Govt. allocation of fund for maintenance of water supply under Sarli Township, Under PHE & WS Division Koloriang.

As per the case record, PIO has not provided information in time.

Being dissatisfied, the appellant filed First Appeal dated 23/10/2024. No hearing has been conducted by the First Appellate in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

**JUDGEMENT ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Bengia Papo on **08/06/2024** filed an RTI application under Form-‘A’ before the PIO-Cum-Executive Engineer (PHE & WS), Koloriang Division, Kurung Kumey District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-‘A’ application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **23/10/2024**. Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **13/01/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 45/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 3 (three) times i.e on 12/11/2025, 19/01/2026 and 06/03/2026. In this hearing of the appeal on 6<sup>th</sup> day of April, 2026, the PIO-cum-Executive Engineer (PHE & WS), Koloriang Division and Appellant, Shri Bengia Papo found absent. However, the appellant has submitted an application addressed to the Hon’ble State Information Commissioner stating that he has received all the information as sought and he is satisfied by the information provided and requesting to dispose of the appeal case No. APIC-45/A/2025.

The Commission accepted the request and appeal case No. APIC-45/A/2025 is disposed of and closed.
