An Appeal Case U/S 19(3) of RTI Act, 2005

Case No. APIC- 699/2025.

APPELLANTS

: Shri Ngwazosa Yobin, Miao near Kali Mandir.

RESPONDENT

: The PIO, o/o the Block Development Officer-cum-Circle Officer Vijoyanagar CD Block Changlang District (A.P)

ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Ngwazosa Yobin for non-furnishing of below mentioned information by the PIO, o/o the Block Development Officer-cum-Circle Officer Vijoyanagar CD Block Changlang District (A.P) as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 19.05.2025:

A) Particular of information: MGNREGA Scheme, Vijoyanagar CD Block especially for 2022.

B) Details of information required:

1. Total fund allocation under MGNREGA in 2022;
2. Details beneficiary list of MGNREGA for 2022;
3. Detail list of DBTL, Bank transaction of the beneficiaries;
4. Location of the work with photograph before and after;
5. Geo- tagged location where works have been executed;
6. Utility certificate (UC) and audit reports of the Financial Accounting Officer (FAO) and
7. Work completion reports.

Brief facts emerging from the appeal :

Records emerging from the appeal disclose that the Appellant, Shri Nwazosa Yobin had requested the PIO for the aforementioned information / documents but failed to obtain the same which prompted him to appeal before the, Deputy Director(RD), Changlang, Changlang District as the First Appellate Authority (FAA) under Section 19(1) of the RTI Act vide his appeal Memo dated 07.07.2025.

There is, however, no record of the FAA's taking the hearing of the appeal but records disclose that the Deputy Director (RD), vide his letter dt.18.07.2025, directed the BDO, Vijoyanagar CD Block to furnish the information to the appellant.

The appellant, apparently, having failed to obtain the information from the PIO despite direction from the FAA, filed his 2nd appeal before this Commission under Section 19(3) of the RTI Act vide Memo of appeal dt. 12.09.2025.

Accordingly, this appeal is listed today on 5th Dec. 2025 but neither party appeared without any intimation.

The non-appearance of the parties, particularly, the appellant has been viewed seriously by this Commission and as such this Commission is constrained to conclude that this appeal is fit to be closed in terms of the caution contained in the Summon Notice dt.19.11.2025 that *in default of parties appearance, on the day of hearing fixed, the matter will be heard and determined in their absence.*

This appeal is, accordingly, closed.
