JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from Shri Riya Taram & Shri Takam Sakap, C/o Hotel River View, Barapani, Naharlagun, Arunachal Pradesh, for non-furnishing of information, by PIO –cum- EE, PWD Jang Division, Tawang District, Arunachal Pradesh, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 14/03/2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"all the relevant documents pertaining to fund sanction/allocation under SIDF, Additional SIDF, BE, Additional BE, RE, Additional RE, SADA, ADA, MLALAD, MPLAD, CCI, SPA, SJETA, CMCSRP, Maintenance and Supply Order for development of entire Jang Division from 2017 till date,".

The above subject has been mentioned in detail under 'Form - A'.

The 1st hearing of this case was held on 22/11/2023. The representative of the PIO Shri Taw Tamar, JE, PWD Jang Division represented on behalf of the PIO. Appellant was represented by Shri Tania June. The representative of the PIO brought the documents sought by the appellant and handed to the representative of the appellant Shri Tania June during hearing of this case. The Court disposed of the case as the information sought by the appellant has been provided by the representative of the PIO in today's hearing.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
