This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Ratan Chetia, Village-Sitpani Moran, P/o, P/s Mahadevpur, Namsai District, Arunachal Pradesh, for non-furnishing of information by the PIO-cum-EE (PHE & WS), Namsai Division, Namsai District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 08/09/2022 regarding Jal Jeevan Mission (JJM) and Non-JJM Water supply projects.
- 2). The 1st hearing was held on 17th February' 2026. The PIO-cum-EE (PHE & WS), Namsai Division, Namsai District, Arunachal Pradesh was represented Er. Gumku Maga, APIO-cum-AE (PHE & WS), Namsai Division. The Appellant Shri Ratan Chetia had appeared before the Commission through video conferencing.
- 3). All the information sought by the Appellant had been furnished; only site inspection had to be conducted. The Commission had directed both the parties to conduct site inspection on 25th February'2026 and intimate to the Commission. But till date the Appellant failed to do so.
- 4). The Commission, in view of the order dated 17th February'2026 decided to dispose of the case.
