The appellant file a RTI Application dated 31/03/2025 seeking Details regarding details Construction of Water Conservation project ar Elyi Senyi Streams under Yachuli Block, Lower Subansiri District.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 25/04/2025. No any hearing has been conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tana Roma Tara on **31/03/2025** filed an RTI application under Form-'A' before the PIO-cum-EE(PWD), Yazali Division, Keyi Panyor District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **25/04/2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **03/09/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 463/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 1 (one) time i.e on 09/02/2026. In this hearing of the appeal on **9th day of February, 2026**, both the PIO-cum-EE(PWD), Yazali Division, Keyi Panyor District and Shri Tana Roma Tara found absent however, a letter has been received from the appellant requesting to dispose of the case No. 463/A/ 2025 and also stating that all the information as he sought has already been furnished and satisfied.

Request accepted and the appeal case is dispose of and closed..
