ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from ShriRiya Taram, Shri Bengia Tahar & Shri Lokam Namdu, for non-furnishing of below mentioned information by the PIO, o/o the (DFO) Pasighat, East Siang District (A.P) as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 09.10.2024

A) Particular of information: To furnish all the Relevant information against the

Released of Fund amounting of Rs. 323.71842 lakhs of LOC for the month of March ,2024 to DFO Account no. 31653694596 for proper implement of the items under CA, WLM & NPV' components of the State CAMPA AOP Vol-i&ii during 2023-2024 under Department of Environment & Forest & Climate Change as per Sanction order,

B) Details of information required:

- 9. Total Area Square of Land with Longitude and Latitude of Area/Exact Location of work Area with LPC Copy.
- 10. Money Receipt /Cash Memo/Challan of all the items/works/Contractors/firms cashbook statement.
- 11. Details of Payment list with Money Receipt of all the Contractors / firms / Enterprise.
- 12. Bank account Statement of OFO or Bank Account Statement of Range Forest Officer (RFO) with its account No. / Give the name of officer who is holding the DDO power with their signature and seal.
- 13. Name of Officers and Officials who Executed/Handled the Aforesaid work/ Prepared DPR/First & Final Bill and made payment.
- 14. Govt. Notification/Cabinet passed Order copy for RFO to prepare DPR/Estimate/First & Final Bill of works/made payment without Engineers.
- 15. All the details of Fund/Amount Transaction to RFO Account from DFO Account.
- 16. Measurement Book (MB) with page number/Hand Receipt and Payees Name.
- 17. Mentioned various deduction of amount as percent from Contractor bill payment by RFO/DFQ.
- 18. Certified Photocopy of all works by concern Officer.

NIT Copy/Date of NIT Tender floated or Conducted/Total number bidders/Total Apply of firms/Name of Selected Firm & Contractors/Press Letter Paper Cutting/Awarded firm details with Cheque book counterfoil/leaf/demand draft/banker cheque/deposited challan and PFMS Transaction details as according to the amount mentioned in work order/sanction order with account Number of firm/ Contractor.

Brief facts emerging from the appeal and the decision :

Records emerging from the appeal disclose that the three appellants had requested the PIO for the aforementioned information/documents but failed to obtain the same which prompted them to appeal before the Chief Conservator of Forest, Govt. of A.P. Central Circle Pasighat, the First Appellate Authority (FAA) under Section 19 (1) of the RTI Act, 2005 vide Memo of Appeal Dated 18.11.2024.

There is, however, no records of the FAA's consideration of the appeal. Hence, the appellants preferred their 2nd appeal before this Commission under Section 19 (3) of the RTI Act. 2005 vide Memo of Appeal dated 13.01.2025 which was accordingly listed for hearing today on 11.07.2025. But none of the parties appeared.

The DFO-cum-PIO, vide his letter dt.27.06.2025 has, however, furnished the replies/information to the appellants on the 22 point queries made in their RTI application dt.09.10.2024, a copy whereof has been forwarded to this Commission.

Since the appellants are absent, it is presumed that they have received the requested documents/replies and are satisfied therewith in view of which this appeal is fit to be disposed and closed as such in terms of the stipulation as contained in the Summons notice dt. 18.06.2025, <u>"Take notice that in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence".</u>
