The appellant file an RTI Application dated 29/10/2024 seeking Details regarding C/o Construction of Auditorium-cum-Conventional Hall at JN College Pasighat in East Siang District during the year 2021-22..

JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tamchi Gungte 26/10/2024 filed an RTI application under Form-'A' before the PIO-Cum- Executive Engineer(WRD), Pasighat Division, East Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 30.11.2024, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 16/01/2025 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 83/2025 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 2 (two) times i.e on 09/07/2025 and 08/10/2025. In this hearing of the appeal on 8th day of October, 2025, the PIOcum-EE(PWD), Pasighat Division is represented by Er. Tapang Tatak, AE but the Appellant Shri Tamchi Gungte found absent, however, he has submitted and application addressed to the State Information Commissioner requesting to dispose of the appeal case No. APIC-83/1015 and stating that he has received all the information as sought and is satisfied.

Request accepted and the appeal case No. APIC-83/2025 is disposed of and closed.
