## JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Lazala Singpho on 25/04/2024, filed an RTI application under Form-'A' before the PIO-Cum-EE, Department of (WRD.) Bordumsa Division, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application.

- Utilization Certificate of completion BE, RE, RIDF, NEC, SIDF.
- Measurement books of all the works under BE,RE, RIDF, NEC, SIDF. i) ii)
- Firms details who did the work. iii)

The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 27/05/2024 the Appellant, again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 5/11//2024 and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No. 310/2024 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission three times i.e on 06/02/2025, 19/04/2025 & 1/07/2025 In this hearing of the appeal on  $1^{st}$  day of July ' 2025. The Appellant Shri Lazala Singpho and the PIO both are found absent during the hearing.

However, the Appellant Shri Lazala Singpho has submitted a letter to the Commission on 6/3/2025, stating that the has received all the information(s) as sought in his Form 'A' application and have requested the Commission for disposal/closure of his appeal on ground of satisfactorily in receipt of all information(s) sought from the PIO.

In view of the above facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed and closed once for all.
