JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Chow Lajamang Mannow on **18/08/2025**, filed an RTI application under Form-'A' before the PIO-Cum-EE, PWD Tezu Division, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **17/10/2025** the Appellant again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **04/12/2025**, and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No. 919/2025(A-peat)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **07/05/2026**.

Details of information sought by the Appellant.

1. Certified copy of category of work charged (W/C) staff serving under your Division.
2. Certified copy of appointment letter of all the W/C staff serving under your Division.
3. Certified copy of place of posting of all the W/C staff serving under your Division.
4. Certified copy of total number of W/C staff with name attached under CE(EZ) PWD/SE PWD, Tezu Circle, PWD Namsai Division etc. give specific reasons why they are attached in the above mentioned office.
5. Certified copy of recruitment rules (RR) of work charged (W/C) Staff from Government of Arunachal Pradesh.
6. Certified copy of Guidelines of regulatory scheme and draft recruitment rules of W/C Staff from competent Authority.
7. Certified copy of approval from competent Authority or SE, advertise details, interview or Viva details, videography of Interview of W/C staff.
8. Certified copy of DPC, trade test of all the W/C staff serving under your Division.
9. Certified copy of Board members formed of all the W/C Staff recruited under your division.
10. Certified copy of present strength of W/C Staff under your division.
11. Certified copy of total strength of W/C Staff under your division.
12. Certified copy of total number with name of W/C staff recruited from other district of the State.

In the 1st hearing held on 7th May 2026, related to the **APIC No-919/2025(Appeal)**. The Appellant Lajamang Mannow, present during the hearing through online mode.

The PIO-cum EE (PWD) Tezu Division Govt .of Arunachal Pradesh, has authorized Smti Tanya Yasap JE (PWD) to represent him today, with an authorization letter.

Heard the Appellant.

The Appellant stated that he received all the information from the PIO except the information listed under Sl. No- L of his Form 'A' but not insisting on the same information to be provided to him, when total no. of W/C staff and their details have been provided. I admit that all the information as sought by me have been provided by the PIO and hence this appeal may be disposed of today itself and closed.

After hearing the Appellant and his statements the Commission doesn't need to further this hearing and therefore, when the information have been received by the Appellant, the ends of this appeal is accomplished and therefore this appeal is disposed and closed once for all.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.


