ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near KV-II School Chimpu, Po/Ps Chimpu, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO -cum- EE(PHE & WS), Namsai Division, Namsai District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 20/09/2025 regarding **total list of Works / projects sponsored by State fund / Central fund or both (such as SIDF/ BE/RE/ RIDF/SADA / ADA / MLA-LAD /SPA/ Article 275 (1)/ PMJVK/ CRIF/ PMDeVINE/ NEC / NESIDS / Non-BADP /JJM/ NRDWM / SBM, Maintenance works etc, executed under the division : from the financial year 2016-17 to 2025-26.**
- 2). **The 1st hearing was held on 12th May' 2026** (Tuesday) at 1100 Hrs. Shri Tamchi Gungte, the Appellant was absent from court hearing. Shri Bupen Kania, PIO-Cum- EE, (PHE & WS), Namsai Division, Namsai Distt. Govt. of Arunachal Pradesh was present through online mode.
- 3). The PIO stated that on 18th January' 2026 the 1st hearing was held in the office Chamber of the Chief Engineer (PHE & WS), Namsai, Division. During the hearing, the point raised by the Appellant was found to be voluminous and vague. Hence, the Appellant was directed to file fresh RTI Appeal seeking specific information. However, as on date no RTI appeal had been received by the PIO from the Appellant.
- 4). Since, the case was being disposed of in absence of the Appellant, the Commission directed the PIO, to furnish the information if sought by the Appellant, in specific terms in the future.
- 5). The case is hereby disposed of and closed.
