JUDGEMENT ORDER

An appeal under section 19(3) of RTI Act, 2005 was received from **Shri Tai Saktar, G-Extension, Naharlagun, ICR, Arunachal Pradesh**, for non-furnishing of information, by **The PIO-cum-Deputy Director, O/o The Director State Council for Science & Technology, Itanagar, ICR, Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 20.11.2020 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"Details information regarding Appointment of Scientific and Non-Scientific staffs in AP remote sensing application centre".

The above subject has been mentioned in detail under 'Form – A'.

The 1st hearing was held on 17th day of October' 2021. The appellant and APIO both were present. Heard both the parties. The appellant informed the Court that the information furnished by the PIO were in-complete. The APIO in his response pleaded before the Court to give few days time to furnish the complete information. The Court directed the APIO to furnish the complete information on or before the next hearing. Accordingly, the Court fixed the next date of hearing for the case on 17th November' 2021.

The 2nd hearing was held on 17th November' 2021. The appellant was absent but the APIO was present. The case was heard ex-parte. Since the appellant was absent, the matter couldn't be discussed further. As such Court gave a chance to the case and fixed another date of hearing for the case on 15th December' 2021.

The 3rd hearing was held on 15th December' 2021. Both the parties were present. Heard both the parties. The PIO furnished documents to the appellant as sought by him before the Court itself. The appellant received the same. The Court directed the appellant to go through the documents received and report his redressals of satisfaction/dissatisfaction on or before next date of hearing fixed. Accordingly, the Court fixed the next date of hearing on 02nd February' 2022.

The 04th hearing was held on 02nd day of February' 2022. Both the parties were absent. Since, both the parties were absent, the matter couldn't be discussed further. Accordingly, the Court fixed another date of hearing for the case on 02nd March' 2022.

The 05th hearing was held on 02nd day of March' 2022. Both the parties were present. Heard both the parties. The PIO informed the Court that all the informations sought by the appellant has been furnished to him. The appellant on his response agreed with the PIO and expressed his satisfaction for all the documents received. The appellant later pleaded for disposal of the case before the Court. As such, the Court directed to dispose of the case and no such hearings for this case will be entertained further in the Commission's Court.

Considering all the above aspects into account, I find this appeal fit to be disposed off as infructuous. And, accordingly, this appeal stands disposed off and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
