ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tania June, E-Sector, PO/PS Naharlagun, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum-DFO, Govt. of A.P., Bhalukpong Division, West Kameng District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 25/05/2023 regarding Expenditure and implementation of under CAMPA Schemes. ARF/VRF/ of entire Bhalukpong Area.

The 2nd hearing is held today on 26th March, 2024 as scheduled. Shri Aduk Paron, the SPIO-cum-DFO, Govt. of A.P., Khelong FD, Bhalukpong Division, West Kameng District, Arunachal Pradesh alone is present. The Appellant Shri Tania June is absent, he was absent in the last hearing also. However, the commission reiterated him to submit his specific list of one work of one financial year in one application. As the appellant's application dated 25/05/2023 has sought information from 2010 to till date. The PIO had submitted that the appellant has not submitted any specific list and as such the PIO could not furnish the information to the Appellant.

The appellant is found continuously absent from the hearing. During the last hearing held on 12th December, 2023 it was clearly directed him to appear before the commission, failing which the case shall be disposed of without any further notice. Today the appellant is again found absent. In pursuance of last hearing the commission decides to dispose of the case.

Therefore, the case is hereby disposed of.
