EX-PARTE JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Chera Taji on **03/07/2025** filed an RTI application under Form-'A' before the PIO-Cum-Director Planning & Investment, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **12/08/2025**, the Appellants again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **11/09/2025** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No-711/2025(Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for hearing on **22/01/2026 & 23/04/2026..**

Details of information sought by the Appellant.

- 1. Furnish the certificate copy of the fund allocation from planning since from 2017 to till date and furnish year wise details.**
- 2. Furnish the certified copy of the administrative approval sanction order.**
- 3. Furnish the certified copy of the guidelines for implantation fund of RE/SIDF/BE/ in the fund from Govt. of Arunachal Pradesh.**
- 4. Furnish the name of implementing agency Department who carryout construction of planning Residential Complex.**
- 5. Furnish the sought documents with paper page number content serially with seal and signature for the PIO or APIO.**

In the 2nd hearing held on 23rd day of April '2026, the Appellant found absent, with a letter of absence. The PIO -cum, Director of Planning and Investment Govt. of Arunachal Pradesh, found absent during the hearing without intimating the reason for his inability to attend the hearing.

The Appellant Shri Chera Taji has submitted a letter to the Commission dated **22/04/2025**, stating that he has received all the information(s) as sought in his Form 'A' application and has requested the Commission for disposal/closure of this appeal on ground of completely in receipt of all information(s) sought from the PIO.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and close. And, accordingly, this appeal stands disposed of and closed once for all.
