FACTS OF THE CASE:

The appellant filed an RTI application dated 16.12.2022 seeking information on various works under MLA / MP LAD FUND, BADF etc in 21-Koloriang Assembly constituency. The PIO did not furnish any reply in response to the RTI application. The appellant then filed a First Appeal dated 20.01.2023. The First Appellate Authority's (FAA) order, if any, is not available on record. Feeling aggrieved, the appellant approached the commission with the instant second appeal.

FACTS EMERGING DURING THE HEARING:

After receipt of the second appeal notices were issued to the parties to appear on 30.06.2023. The appellant alone appeared on 30.06.2023. The appellant submitted that the PIO did not furnish any reply to his RTI application and pleaded that requested information should be furnished to him. The commission after hearing the appellant and perusal of record directed the PIO to furnish complete information within 20 days and adjourned the case to 01.09.2023. The appellant appeared on 01.09.2023 and submitted that in spite of the order of the commission the PIO did not provide information to him. The PIO was absent without any intimation to the commission. However, the PIO was heard through audio hearing. During the hearing the PIO had assured to provide the requested

information to the appellant. The commission adjourned the hearing to 03.11.2023 with direction to the PIO to furnish complete information to the appellant. None appeared on 03.11.2023. On the request of the appellant hearing of the case was adjourned to 22.12.2023.

The appellant alone appears before the commission and submits that the PIO has furnished complete information.

DECISION:

Keeping in view the facts of the case and submission made by the appellant during the hearing the commission is of the view that PIO has furnished complete information. No further action lies. **Appeal is disposed of accordingly.**
