The appellant file an RTI Application dated 05/05/2025 seeking Details regarding Cycle Track PAI Gate to Ziro Air Field for the year 2021-22.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 23/06/2025. No any hearing was conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tap Sajan & Shri Nabam Sonu on **05.05.2025** filed an RTI application under Form-'A' before the PIO-cum-Executive Engineer (PWD), Ziro Division, Lower Subansiri District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **23.06.2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **29.07.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 601/A/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for one time i.e on 03/12/2025. In this hearing of the appeal on 3rd day of December, 2025, both the parties PIO-cum- (PWD), Ziro Division and the appellants Shri Tap Sajan & Shri Nabam Sonu found absent however, the appellants however, the appellants has sent a letter addressed to the Commission stating that he has received all the information as sought by him and satisfied.

Accordingly, this appeal case No. APIC-601/A/2025 is disposed of and closed.
