**DISMISSAL JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant Shri Tamar Marbom on **02/09/2024** filed an RTI application in form 'A' before the PIO-cum-District Horticulture Officer, (DHO), Upper Subansiri District, Daporijo, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellant being not furnished with the required information(s) from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **14/11/2025**. Appellant again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **18/12/2025** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC- No. **924/A/2025** (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **05.05.2026**.

**Details of Information sought from the PIO;**

1. Furnish a copy of Amount Received in Total CTC.
2. Furnish a copy of Amount disbursed Block wise.
3. Furnish a copy of Criteria for being Beneficiaries.
4. Furnish a copy of weather the Beneficiaries awarded the benefits in Kind (Material) or cash.
5. Furnish a copy of signature (Received letter of beneficiaries against the items received by them).
6. Furnish a copy of Utilization certificate.
7. Furnish a copy of process of bidding form advertisement till final payment of bill as per instruction and guideline issued by the Director of Horticulture Cum mission Director chimpu.

In the first and final hearing of the appeal held on 5<sup>th</sup> day of May' 2026 both the parties are present during the hearing before the court of the Commission.

**Heard the Appellant;**

The Appellant stated that he has not been furnished with any information from the PIO till now.

**Heard the PIO;**

The PIO stated that he has brought whatever information available in his office in anticipation of the Form-A though, it is not exactly clear as to what information on what subject the Appellant has applied for the information.

**After hearing both the parties the Commission hereby orders;**

- i) The Appellant to collect the information brought by the PIO in the court of the Commission.
- ii) In the event of the Appellant finds that in-complete information have been furnished to him, the Commission grants him the liberty to file a fresh application for the same set of information again.

Under the above circumstances while the Form-A of the Appellant though not maintainable and not complete, the Commission heard the Appellant and the PIO, and incidentally the PIO has brought some information(s) to which the Commission ordered to hand over to the Appellant.

In the eventual procedure of today's hearing the Commission finds that the Form-A of the Appellant is in-complete, and therefore, the Commission hereby dismiss this appeal and close it with liberty given to the Appellant to file for fresh application if need be.

In view of the above facts and circumstances the Commission, find this appeal fit to be dismissed and closed. And accordingly this appeal stands dismissed and closed.
