Information sought :

The appellant file a RTI Application dated 30/05/2024 seeking Details Expenditure and implementation of MLA LAD in Kamle District.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 11/04/2023. No hearing has been conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Palen Laa absent.
Respondent : PIO-cum-DPO, Ragais represented by Shri Giper Biri, UDC.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Palen Laa on **09/03/2023** filed an RTI application under Form-'A' before the PIO-cum-DPO, Raga, Kamle District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **11/04/2023**, Appellant, again having not

received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **12/05/2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 504/2023 & APIC-505/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 16 (sixteen) times i.e on 29/06/2023, 10/08/2023, 04/10/2023, 13/11/2023, 22/01/2024, 03/06/2024, 03/07/2024, 18/09/2024, 21/08/2024, 30/10/2024, 20/11/2024, 18/12/2024, 05/02/2025, 19/03/2025, 23/04/2025, 11/06/2025 and 06/10/2025. In this hearing of the appeal on 6th day of October, 2025, the PIO-cum-DPO, Raga is represented by Shri Giper Biri, UDC-cum- Accountant and the appellant Shri Palen Laa found absent without any intimation to the Commission.

As per the order dated 11/06/2025 all the information which are available have been provided to the appellant and the information which are not available have been declared through Affidavit Declaration.

As per the case record, the appellant was given last opportunity to be present but the appellant has been consecutively absent for last 4 hearings.

The Commission deems that the appellant is satisfied with whatever information provided to him and does not want to pursue the appeal case any more.

Therefore, this appeal case is disposed of and closed in his absence.

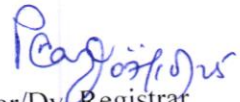
