ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Gichik Tadik, Dikrong Colony, Nirjuly, Near Govt. Middle School Dikrong, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the PIO -cum- EE(PWD), Tali Division, Kra Daadi District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 27/12/2025 regarding Special Assistance to States for Capital Investment-2024-25.
- 2). The 1st hearing was held on 12th May' 2026. Er. Tare Murtem, PIO -cum- EE(PWD), Tali Division, Kra Daadi District, Arunachal Pradesh, was represented by Shri Gem Dol, UDC, o/o of the EE (PWD) Tali Division. The Appellant Shri Gichik Tadik appeared in person before the Court.
- 3). The Commission had directed the PIO to furnish all the available information to the Appellant within fifteen days from the date of issue of the order dated 12th May'2026. In case information as sought were not available in his office, the PIO should give justifiable reasons in writing to the Appellant under intimation to the Commission. Failing to comply with the direction of the Commission could result in the PIO being penalized heavily and directed to compensate the Appellant under the provisions of the RTI Act 2005.
- 4). The Commission had also asked the Appellant to receive information from the PIO and intimate his satisfaction or dissatisfaction.
- 5). The Appellant vide letter dated 08/06/2026 intimated the Commission that he had received information from the PIO and appealed to dispose of the case.
- 6). The Commission in view of the Appellant's letter decided to dispose of the case.
- 7). **Therefore, the case is hereby disposed of.**
