Information sought :

The appellant file an RTI Application dated 03/10/2024 seeking Details regarding 3rd year Operation, Maintenance of CA Plantation under CAMPAQ Scheme 2023-24.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 27/11/2024. First Appellant Authority had been conducted hearing in his jurisdiction on 05/12/2024. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Tamchi Gungte absent.
Respondent : PIO-cum-DFO, Kehllog Forest Division is represented by RFO Shri Tanga Murtem through VC.

JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tamchi Gungte 03/10/2024 filed an RTI application under Form-'A' before the PIO-Cum- DFO, Khellong Forest Division, West Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 27/11/2024, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 15/01/2025 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 78/2025 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 4 (four) times i.e on 07/07/2025, 06/10/2025, 11/03/2026 and 04/05/2026. In this hearing of the appeal on 4th day of May, 2026, PIO-cum-DFO, Khellong Forest Division is represented by Shri Tanga Murtem, RFO through VC but the appellant Shri Tamchi Gungte found absent inspite of giving cautioned as per the last order. The PIO had stated that the sought documents had already been provided to the appellant.

The appellant was given last chance to intimate to the Commission whether he received the information or not. The appellant was also warned that if no intimation is made the Commission will presume that he has received the information and is satisfied.

The appellant has been absent in consecutive 2 (two) times without any intimation to the Commission

Therefore, the Commission presumes that the appellant has received all the information sought and is satisfied. Accordingly, the appeal case No. APIC-78/2025 is disposed of and closed.


