JUDGEMENT ORDER

An appeal under section 19(3) of RTI Act, 2005 was received from **Shri Tadar Tarish, Chimpu-III, Itanagar, PO/PS-Chimpu, ICR, Arunachal Pradesh**, for non-furnishing of information, by **The PIO-cum-Executive Engineer, IMC-Part I Itanagar & Executive Engineer, IMC-Part II, Naharlagun, ICR, Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 14.10.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

"Budget Speech 2019 for Solid Waste Management System work at Karsingsa and Chimpu Namely 'Augmentation of Waste Management System in Capital Complex and Development of external infrastructure of landfill sites at Karsingsa and Chimpu Rs.6.00 Cr.'"

The above subject has been mentioned in detail under 'Form - A'.

The 1st hearing was held on 08th day of February' 2023. Both the parties were present. Heard both the parties. The PIO furnished the information sought by the appellant before the Court itself. The appellant received the same. The Court directed the PIO to go through the documents received and inform his satisfaction/dissatisfaction on or before next date of hearing fixed on 01st March' 2023.

In-between, on dated 27th February 2023, the Commission received a letter(enclosed) from the appellant, whereby expressing his satisfaction for all the documents received and pleaded for disposal of the case. As such the Commission directed to dispose of the case and no such hearings for this case will be entertained further in the Commission's Court.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
