JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant Shri Ratan Chetia on 19/12/2024 filed an RTI application in Form'A' before the PIO-cum-EE, Deomali Electrical Division, Tirap District, Govt. of Arunachal | Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellant being not receiving the information from the PIO filed the First Appeal before the First Appellate Authority (FAA) on 20/03/2025. The Appellant again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 28/07/2025 and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC-No. 599/A/2025 (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on 16.09.2025 wherein the Appellant is present through online mode during the hearing before the Commission.

The PIO-cum-Executive Engineer, Deomali Electrical Division, Tirap District, Govt. of Arunachal Pradesh found absent during the hearing before the Commission.

Date of Hearing: 16th September 2025.

- 1. This appeal has been brought before the Commission by the Appellant, Shri Ratan Chetia, against the decision of the Public Information Officer (PIO), Executive Engineer, Power (Electrical) Deomali Division, regarding his application under the Right to Information (RTI) Act.
- 2. During the first hearing on 16th September 2025, the Appellant clarified in open court that he had filed the Form A Application on behalf of his friend, Shri Thangam Wangchu, a retired Army personnel. However, the Appellant failed to present any evidence of authority to act on behalf of Shri Wangchu in the form of a duly certified power of attorney or any other appropriate authorization.
- 3. The Commission observes that the absence of proper authorization not only undermines the integrity of the RTI process but also imposes unnecessary burdens on the PIO and the resources of the public office. It is imperative that the procedures established under the law are adhered to strictly, as they are designed to ensure transparency and accountability.
- 4. The Appellant's failure to provide sufficient legal backing for his application to act on behalf of another individual, particularly under the provisions of the RTI Act, reflects a serious procedural deficiency. Such insufficient procedures not only contravene legal requirements but

also disrupt the functioning of the office of the PIO, compelling them to attend multiple court hearings that could have been avoided.

- 5. It is noted that the PIO is required to travel from Deomali to Itanagar for these hearings, a journey that is time-consuming and resource-intensive. The Commission finds it imperative to maintain the sanctity of the RTI process while safeguarding public resources from unnecessary wastage.
- 6. In light of these considerations, the Commission is constrained to dismiss the appeal forthwith due to the insufficiency of authorization presented by the Appellant.
 - 7. Therefore, the appeal is hereby dismissed.

Order:

The instant appeal is dismissed.
