Information sought :

The appellant file an RTI Application dated 25/10/2024 seeking Details regarding construction of Cultural Hall at Kungzang Chockorling Community Centre, Bomdila.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 26/11/2024. No hearing has been conducted by the First Appellate in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Mamu Sono absent.

Respondent : PIO-cum-EE (WRD), Bomdila Division present.

JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Mamu Sono on **25.10.2024** filed an RTI application under Form-'A' before the PIO-Cum- Executive Engineer (PWD), Bomdila Division, West Kameng District, Govt. of Arunachal Pradesh whereby, seeking various

information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **26.11.2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **14.02.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 159/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two time i.e on 10/09/2025 and 10/11/2025. In this hearing of the appeal on 10th day of November, 2025, both the parties the PIO-cum-EE (PWD), Bomdila Division and the appellants Shri Mamu Sono found absent without any intimation to the Commission.

On the last hearing PIO has stated before the Commission that the information sought by the appellant has already been provided and received by the appellant. The appellant was directed to be present in the next date of hearing and caution that if he failed to be present in the hearing, the appeal case will be heard in his absence.

Today the appellant is absent without any intimation, the Commission presumes that the appellant has received the sought information and is satisfied. Therefore, the Commission deems fit to dispose of this appeal case. This appeal case No. APIC-159/2025 is disposed of and closed.
