Information sought :

The appellant file an RTI Application dated 07/08/2024 seeking Details regarding Recruitment Rules of TGT and PRT.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 22/10/2024. No hearing was conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Gollo Hari and Shri Tarh Taram 07.08.2024 filed an RTI application under Form-'A' before the PIO-cum-Deputy Director of School Education, Ziro, Lower Subansiri District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the

information received from the PIO, filed the First Appeal before the First Appellate Authority on 22.10.2024, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 12.11.2024 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as APIC No. 325/2024 and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 7(seven) times i.e on 27/01/2025, 24/02/2025, 05/05/2025, 18/08/2025, 27/09/2025, 09/03/2026, 13/04/2026 and 25/05/2025. In this hearing of the appeal on 25th day of May 2025, the PIO-cum-DDSE, Ziro, Lower Subansiri District and the appellant Shri Gollo Hari & Shri Tarh Taram present in person.

As per the order dated 13/04/2026, PIO has filed Affidavit Declaration stating that the documents sought for Waiting list of TGT/PRT are not available in the record.

Therefore, the Commission deems fit to dispose of and close this appeal case, as no more documents available to be furnished to the appellant.

Therefore, the appeal case No. APIC-325/2024 is disposed of and closed.
