Information sought:

The appellant filed an RTI application dated 26.12.2024 seeking following information regarding execution of Amounting to 1.Rs.1563.11Lakhs (Non-Plan, RE, SADA, CAMPA.BE Head) 2022-2023 to till date.

A) Details of information required:

1. Technical sanction order, DPR copy.
- 2.Furnished the NIT/NIQ details with Newspaper cutting.
- 3.Contractor Details/Agency.
- 4.work order.
- 5.Measurement Book details.
- 6.Geo tag details photography of project site, GPS Map camera copy.
- 7.Cheque counterfoils, billing transaction details or PFMS details.
- 8.First&Final Bill statement/Abstract.

- B) Furnish the specific details of items mentioned:
- Name of beneficiaries, firm, contractor with details address, specific location, contact numbers and contact details of the furnished beneficiaries, contract firm/agency.
 - Mode of details of payment with specific date and year against the beneficiaries, firm, contract firm/agency with amount in figure in each
 - Voucher details and money receipt of payment made to each beneficiary, firm, contractor of furnished beneficiaries, contract firm/agency.
 - Beneficiaries Identity Proof like, Aadhar card, voter ID with contact number.
 - Furnished the Beneficiaries Signature during cheque/Cash received.
 - Site inspection of work/verification.

The following were present.

Appellant : Absent.

Respondent PIO : Absent. Shri Tanga Murtem, RFO has represented the PIO through VC. He was not aware of FAA's Order dated 18.3.2025.

Decision:

The Commission after adverting to the facts and circumstances of the case, and perusal of the records and hearing the party, observes that the FAA has heard the appeal and disposed of the appeal case on 18.03.2025 with a direction to PIO to furnish the required information available with him to the appellant within 15 days from the date of issue of the order with intimation to their office. However, it seems that there is a miscommunication between the new PIO and the FAA about hearing of this appeal case. Therefore, the FAA's judgement order is upheld.

The PIO is directed to furnish the information to the appellant within three weeks from the date of issue of this order i.e. on or before 03.03.2026.

The appellant is directed to submit a written status report about information received from the PIO within one month from the date of issue of this order to the PIO with a copy to this commission.

Next date of hearing shall be fixed on receipt of compliance report of this order from the appellant and PIO. In case no compliance report is received at commission from the PIO and appellant within stipulated time, this appeal case shall stand closed.
