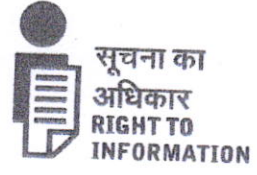

**ORDER**

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Dogra Sagro, Gandhi Colony Bomdila, West Kameng District, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum-DFO, Govt. of A.P., Khellong Division, Bhalukpong, West Kameng District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 12/02/2023 regarding **CAMPA, CAT Plan, Civil works etc.**

**The 2<sup>nd</sup> hearing is held today on 19<sup>th</sup> March, 2024 as scheduled.** Shri Aduk Paron, the SPIO-cum-DFO, Govt. of A.P., Khellong Division, Bhalukpong, West Kameng District, Arunachal Pradesh is present. The appellant Shri Dogra Sagro is absent. In the 1<sup>st</sup> hearing held on 5<sup>th</sup> December, 2023 the appellant remained absent submitting a letter stating that due to his vehicle broke down on the way to the commission he is unable to attend the court hearing. The Commission considering his appeal giving reasonable opportunity fixed one more date for hearing. However, it is found that the appellant remains absent in the 2<sup>nd</sup> hearing also with lame excuse of domestic problem.

In observance of the above and caution issued in the 1<sup>st</sup> hearing the commission decides to dispose of the case in view of larger public interest.

**Therefore, the case is hereby disposed of.**
