**Information sought:**

The appellant filed an RTI application dated 25.07.2025 seeking following information regarding PMKSY SCHEME AT JOPU NONGO RILO PHASE- V FOR THE YEAR 2024-25.

1. certified copy of Copy of Sanction order.
2. certified copy of Copy Details Project Report (DPR) of the Project/Scheme.
3. certified copy of Copy Technical Sanction (TS) COPY
4. certified copy of Copy with Details of Payment made to the beneficiaries by case, Cheque, DBT, PFMS if any.
5. Details of Geo Tagging for said project.
6. certified copy of Copy of Notice Inviting Tender (NIT) for said project
7. Name of the firm /bidder who won the tender of the said project.
8. details of Physical Progress/Inspection report.
9. photocopy/Xerox copy Photograph of Projects in colouring form.

10. Completion/Utilization Certificate if available, if not please specify.
11. certified copy of minutes of meeting against WCD 2.0-11 at Jopu Nongo Rilo.
12. Certified copy with details of Committee for Watershed Development fund.
13. Minutes of Gram Sabha Meeting.
14. details of List of self-Help groups for Watershed project at Jopu Nongo Rilo.

**Relevant facts emerged during hearing:**

Previous Hearing:

First : 20.03.2026

Order of the 1<sup>st</sup> hearing- *"The appellant sought one-week time to study the information document which has been granted. The appellant is directed to file a written submission to this commission on the satisfactory status of information received by him within 10 days from the date of issue of this order. In case of any shortfall in the information received, the appellant is directed to specify the shortfall within the ambit of his RTI application to the PIO within 10 days from the date of issue of this order under intimation to this commission court."*

The following were present.

**Appellant** : Present. He states that he has received the information as sought for against financial year 2024-2025. He wanted the information of Ph-V scheme of 2024 – 2025 citing a sanction order issued in June'2025.

**Respondent PIO** : Shri Bamang Hawayi, EO (RE) represented the PIO. He states that there is no Scheme called PMKSY at Jopu Nongo Rilo Ph-V. However, all information pertaining PMKSY at Jopu Nongo Rilo for the financial year 2024-2025, as applied for in RTI application, has already been furnished to the appellant.

On interjection the appellant wanted information against another PMKSY scheme sanctioned in June'2025.

- Clarified that June 2025 falls within financial year 2025 – 2026 and original RTI application was for the financial year 2024-2025.

**Decision:**

The Commission after adverting to the facts and circumstances of the case, and perusal of the records, hearing the parties observes that the appellant has already received information furnished by the PIO. The written submission filed by the appellant dated 25.3.2026 is pertaining to sanction order of Ph- V.

Whereas, the representative of the PIO has clarified that there is no sanction order called PMKSY Jopu Nongo Rilo Ph-V.

Whereas, the appellant has already received the information for financial year 2024-2025 of the said scheme. Thus, this appeal case is fit to be closed.

**This appeal case is closed and dispose of accordingly at the commission.**
