Information sought:

The appellant has filed an RTI application dated 04.09.2025 seeking following information regarding to payment of compensation in the construction of road in Upper Subansiri District under Frontier Highway.

Details of information required: - For furnishing certified true copy of

1. Notification for acquisition of land for construction of road in Upper Subansiri District under Frontier Highway.
2. Copy of fund sanction order for the aforesaid roads.
3. Compensation assessment of land affected persons.
4. Paid up A/Roll of payment of Land compensation to the affected and other relevant documents, if any.

Period for which information is asked for: 2020-2025.

The following were present.

Appellant : Present. He states that information pertaining to serial 1 and 2 in RTI application has been received. The PIO has transferred the RTI information query at serial no. 3 and 4 to the PIO cum DLRSO Upper Subansiri District.

Respondent PIO : Joined hearing lately.

Decision:

The commission after adverting to the facts and circumstances of the case, perusal of the records and hearing the parties, observes that the appellant has already received information as sought at serial no. 1 and 2 in RTI application.

Whereas, the PIO has transferred the following RTI query at serial no. 3 and 4, not being available in his office, to the PIO cum DLRSO Upper Subansiri District:

- 3) Compensation assessment of land affected persons.
- 4) Paid up A/Roll of payment of land compensation to the affected and other relevant documents, if any.

Whereas, as per NO.F.10/2/2008-IR dated 24.9,2010 clause (iii) of Para 3 of which provides That "if a person makes an application to the public authority for information, a part of which is available with that public authority and the rest of the information is scattered with more than one other public authorities, the Public Information Officer (PIO) of the public authority receiving the application should give information relating to it and advise the applicant to make separate applications to the concerned public authorities for obtaining information from them. It further provides that if no part of the information is available with the public authority receiving the application but scattered with more than one other public authorities, the PIO should inform the applicant that information is not available with the public authority and that the applicant should make separate application to the concerned public authorities for obtaining information from them. The matter has been examined in consultation with the Chief Information Commissioner, Central Information Commission and it has been decided to advise the PIOs that if the details of public authorities who may have this information sought by the applicant are available with the PIO, such details may also be provided to the applicant."

The appellant is directed to file fresh RTI application to the PIO cum DLRSO O/o Deputy Commissioner, Daporijo for aforesaid RTI query at serial no. 3 and 4.

The commission is of the opinion that this appeal against the PIO o/o the Director Land Management Department and FAA – Director, Land Management, govt. of Arunachal Pradesh is fit to be closed.

This appeal case is closed and dispose of accordingly at this commission.
