Information sought :

The appellant file a RTI Application dated 24/06/2025 seeking Details regarding certified copy of all relevant documents for appointment to the post of BDO, Mebo CD Block in respect of Shri Tamin Rallen.

As per the case record, PIO had furnished the sought document.

Being dissatisfied, the appellant filed First Appeal dated 24/06/2025. No hearing was conducted by the First Appellate Authority in his jurisdiction but information sought had been provided to the appellant. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Michal Tayeng on **09/05/2025** filed an RTI application under Form-'A' before the PIO-cum-Dy. Director, Rural Development Department, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **09.06.2025**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **07/11/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 835/A/2025**.and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for first time i.e on 01/06/2026. In this hearing of the appeal on 1st day of June, 2026, both the parties the appellant Shri Michal Tayeng present in person and the PIO-cum-Dy. Director (RD) is represented by Ms. Tongyang Annu, APIO.

APIO stated that all the information sought by the appellant has been furnished to the appellant. The appellant has no objection in closing of this appeal case.

Therefore, this appeal case No. APIC-835/A/2025 is disposed of and closed.
