Information sought :

The appellant file a RTI Application dated 26/09/2023 seeking Details regarding Schemes XIV & XVFC Grants, RGSA Schemes and SOR State Grant.

As per the case record, PIO did not provide the sought information.

Being dissatisfied, the appellant filed First Appeal dated 27/10/2023. No hearing has been conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Mamu Sono present in person.

Respondent : PIO-cum-PD/DPDO, Seppa present in person.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Mamu Sono on **26.09.2023** filed an RTI application under Form-'A' before the PIO-cum-PD/DPDO, Seppa, East Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **27.10.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **09.09.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 1118 (R)/2023(1115/2023)**.and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for seven times i.e on 79/01/2025, 24/02/2025, 26/03/2025, 28/04/2025, 18/08/2025, 29/09/2025 and 09/03/2026. In this hearing of the appeal on 9th day of March, 2026, both the parties the appellant Shri Mamu Sono and the PIO-cum-PD/DPDO, Seppa present in person.

The appellant stated before the Commission that he is satisfied by the information provided and requested to dispose of the appeal case No. APIC No-1118(R)2023(1115/2023).

Request accepted and the appeal case is disposed of and closed.


