JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Khya Changrang on **21/11/2024** filed an RTI application under Form-'A' before the PIO-Cum- SE Design & Planning Itanagar, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **9.10.2024**, the Appellant again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **12.9.2024** and the Registry of the Commission (APIC), having receipt of the Appeal registered it as **APIC No-359/2024(Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for hearing on **24/4/2025,22/07/2025/30/10/2025 & 10/03/2026.**

Details of information sought by the Appellants.

1. Copy of service Book
2. Continuing details of employer service records
3. Including appointment , promotion transfer for leaves records and other service related entire.
4. Copy of Pay and Allowance records first three months of service joining and the month of June to August 2024 including salary investment deduction and other financial benefits
5. Copy pf appointment letter and promotion orders
6. Copy of disciplinary action records.
7. Copy of service tenure certificate employees service duration at various position.

In the 4th hearing on **10th day of March '2026**, the Appellant found absent, with a letter **dated 03/02/2026**, submitted to the Commission. The PIO -cum, SE Design & Planning Itanagar, also found absent during the hearing without intimating the reason for his inability to attend the hearing.

The Appellant Shri Khya Changrang has submitted a letter to the Commission on **03/02/2026** stating that he has received all the information(s) as sought in his Form 'A'

application and has requested the Commission for disposal/closure of this appeal on ground of completely in receipt of all information(s) sought from the PIO.

In view of the above, facts and circumstances the Commission, find this appeal fit to be disposed and closed. And, accordingly, this appeal stands disposed of and closed once for all.


