JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant, Shri Pisa Tapam on **08/01/2024** filed an RTI application in form 'A' before the PIO-cum-District Land Revenue & Settlement Officer (DLRSO), Koloriang, Kurung Kumey District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellant being not receiving the information from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **12/02/2024**. Appellant again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **21/03/2024** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC- No. **150/2024** (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **14.05.2024, 24.09.2024, 14.11.2024, 21.01.2025, 20.03.2025, 05.06.2025, 16.09.2025, 13.01.2026, 16.04.2026 & 02.07.2026.**

Details of Information sought from the PIO;

- i) Furnish the details list of LPC issued in favour of applicants from the land branch in entire Kurung Kumey District.
- ii) Furnish the details required document submitted by the applicant for obtaining LPC.
- iii) Furnish the details fees receipt while issuing of LPC in favour of applicant.
- iv) Furnish treasury challan of each applicant against issue of LPC.
- v) Furnish revenue collection data year wise in entire Kurung Kumey District.

Period for which information: 2020-2021, 2021-2022, 2022-2023

In the tenth hearing held today on 02.07.2026 the Appellant is present during the hearing before the Commission.

The PIO-cum-DLRSO, Koloriang, Kurung Kummey District, Govt. of Arunachal Pradesh, found absent despite notice for hearing issued to him for today on 16.04.2026.

Heard the Appellant;

The Appellant stated that the PIO has provided him the information mentioned in the S/No. a of his Form-A but the information mentioned under S/Nos. b, c, d & e have not been furnished to him till today.

Today is the 10th hearing of this appeal the Appellant submitted before the Commission to dispose of this appeal with directive from the Commission to the PIO-cum-DLRSO, Koloriang, Kurung Kummey District, Govt. of Arunachal Pradesh to furnish the remaining information applied under the Serial Nos. b, c, d & e of the Form-A.

After hearing the Appellant the Commission hereby consider the submission and the request of the Appellant with the following orders;

- i) The PIO-cum-District Land Revenue & Settlement Officer (DLRSO), Koloriang, Kurung Kummey District, Govt. of Arunachal Pradesh is ordered to furnish the information applied under S/Nos. b, c, d & e of the Form-A of the Appellant within 30 (thirty) days from today.
- ii) The Appellant to intimate the Commission the receipt/non-receipt of the information from the PIO-cum-DLRSO, Koloriang, Kurung Kummey District, Govt. of Arunachal Pradesh after the expiry of 30 days from today.
- iii) In the event of failure to furnish the information by the PIO-cum-DLRSO, Koloriang, Kurung Kummey District, Govt. of Arunachal Pradesh to the Appellant, the Commission will initiate action as provided under RTI, Act, 2005 against the PIO.
- iv) With the above order this appeal is hereby disposed of as requested by the Appellant himself in the open court today on this 2nd day of July' 2026.

In view of the above facts and circumstances the Commission, find this appeal fit to be disposed of and closed. And accordingly this appeal stands disposed of and closed.




