JUDGEMENT ORDER

An appeal under section 19(3) of RTI Act, 2005 was received from Shri Tania June, C/o Post Office, Naharlagun, Capital Complex, Arunachal Pradesh, for non-furnishing of information, by The PIO-O/o The Director, Department of Science & Technology, Itanagar, PIN-791111, Arunachal Pradesh, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 27.01.2023 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding :

"Regarding appointment of under Group A/Group B/Group C/ Group D/ASO/ All MTS Post of Establishment and entire District AP."

The above subject has been mentioned in detail under 'Form -A'.

The 1st hearing for the case was held on 22nd day of November' 2023. The appellant & the APIO was present. Heard both the parties. The APIO furnished the documents sought by the appellant before the Court itself. The appellant received the same. The Court directed the appellant to go through the documents received and inform his satisfaction/dissatisfaction on or before next date of hearing fixed on 20th December' 2023.

The 2nd hearing was held on 20th day of December' 2023. Both the parties were present. Heard both the parties. The appellant informed the Court that the documents furnished by the PIO were incomplete. The Court directed the PIO to furnish complete documents to the appellant on or before next date of hearing fixed on 17th January' 2023.

The 3rd hearing was held on 17th day of January' 2024. Both the parties were absent. Since, both the parties were absent the matter couldn't be discussed further. As such the Court fixed another date of hearing for the case on 31st January' 2024.

The 4th hearing was held on 31st day of January' 2024. Both the parties were absent. The appellant was absent for 02(two) consecutive hearings without any intimation to the Court. Hence, it was presumed by the Court that he is fully satisfied with all the information received from the PIO and doesn't want to pursue the case further. Therefore, the case is disposed of and no such hearings for this case will be entertained further in the Commissions' Court.

Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.
