**JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant, Shri Chow Chali Simit on **13/01/2025** filed an RTI application in form 'A' before the PIO-cum-EE, PHE & WSD, Namsai, Namsai District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application. The Appellant being not satisfied with the information received from the PIO filed the First Appeal before the First Appellate Authority (FAA) on **17/02/2025**. Appellant again having not received the required information from the FAA, filed the Appeal before the Arunachal Pradesh Information Commission on **04/11/2025** and the Registry of the Commission (APIC) having receipt of the Appeal registered it as APIC-No. **393/A/2025** (Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **26.02.2026 & 19.05.2026.**

**Details of Information sought from the PIO;**

1. Certified Copy of M/S B.M Enterprise contractor registration certificate or Trade license certificate.
2. Certified Copy M/S B.M Enterprise Proprietor name.
3. Certified Copy Of Work order/supply order issued in the name of the firm/TRADING License from 2020 to till date.
4. Certified Copy No relationship Certificate of staffs serving under O/o EE, Namsai Division, PHE & WSD of M/S B.M Enterprise issued by EE, Namsai Division.
5. Certified Copy of bill made in favour of M/S B.M Enterprise from AE, Namsai Sub-Division Office from 2020 to till date.
6. Certified Copy of no relationship between M/S B.M Enterprise proprietor/Owner and AE, Namsai Sub-Division.
7. Certified Copy of Cheque/Demand draft issued in favour of M/S B.M Enterprise from 2020 to till date.

In the second hearing of the appeal both the parties are present through online mode during the hearing before the Commission.

**Heard the Appellant;**

The Appellant stated that the PIO has not been provided any information till today.

**Heard the PIO;**

The PIO stated that as per the order of the First Appellate Authority (FAA) all the information(s) are ready to be furnished to the Appellant.

After hearing both the parties, the Commission hereby observes;

Upholding the order of FAA-cum-SE, PHE & WS, Eastern Zone, Namsai, order dated 28<sup>th</sup> day of March' 2025, the Commission hereby order the PIO to provide the information under Serial No. 4 of the Form-A of the Appellant in particular to Serial Nos. A, B, C, D & E the PIO has to provide the information to the Appellant, free of cost, without charging fees for the information.

Under the above observation, the Commission order the PIO to provide the above listed information to the Appellant free of cost.

In view of the above observation and circumstances the Commission, find this appeal fit to be disposed of and closed. And accordingly this appeal stands disposed of and closed.
