Sub: **Initiation of disciplinary action against the PIO-cum-Executive Engineer, RWD, Daporijo Division, Upper Subansiri District, Govt. of A.P, for non compliance of the Court order of Arunachal Pradesh Information Commission (APIC).**

Ref: **Section 20(2) of RTI, Act, 2005.**

Sir,

Whereas, it has come to the attention of the Arunachal Pradesh Information Commission, that the Public Information Officer (PIO)-cum- the Executive Engineer, RWD, Daporijo Division, Upper Subansiri District, has failed to comply with the judgment by the court of the Arunachal Pradesh Information Commission (APIC) dated **09.09.2025** concerning an appeal filed under Section 19(3) of the RTI, Act, 2005 against their office.

And whereas, the matter came up for hearing before the Commission on 18.06.2024, 30.07.2024, 26.11.2024, 04.02.2025, 08.04.2025 and 09.09.2025.

And whereas, after 6 (six) hearings the Commission delivered the judgment in favour of the Appellant Shri Niaye Lingri on 9<sup>th</sup> September' 2025 with orders to the PIO;

- 1) To provide all the information(s) as applied by the Appellant completely, within 1 (one) month from today i.e 09/09/2025, failing which strict action as provided under RTI, Act 2005 will be initiated against the PIO.
- 2) To compensate the travelling expenses of the Appellant who has travelled from Lingri Village, Upper Subansiri District to Itanagar for attending the hearing of the appeal for all the 6 (six) hearings for which the Commission ordered the PIO-cum-Executive Engineer, RWD, Daporijo Division, Upper Subansiri District, Govt. of Arunachal Pradesh to pay an amount of Rs. 10,000/- (Rupees Ten Thousand only) within 1 (one) month from the date of the order to the Appellant.
- 3) The said amount to be deposited to the Appellant, Shri Niaye Lingri **Bearing Bank Account No. 34843598928, SBI Nirjuli Branch, Arunachal Pradesh.**

And whereas, on dated 28/10/2025 the Appellant Shri Niaye Lingri has submitted an intimation letter to the Arunachal Pradesh Information Commission for non furnishing of information by the PIO-cum-Executive Engineer, RWD, Daporijo Division, Upper Subansiri District, Govt. of Arunachal Pradesh despite the order of the Arunachal Pradesh Information Commission which is viewed as a contempt of the Court order of Arunachal Pradesh Information Commission (APIC).

Under the provisions of Section 20(1), (2) Arunachal Pradesh Information Commission hereby directs the Secretary, RWD, Govt. of Arunachal Pradesh to initiate disciplinary action against the said Executive Engineer, as per the Service Rules applicable to him for violation of Sub-Section (1) of Section 7 of RTI, Act, 2005 AND to provide the information to the Appellant.

Whereas, the PIO was ordered to furnish all information(s) sought which are available in the office of the PIO to the Appellant within a month from the date of receipt of the judgment, and whereby the judgment was pronounced on 9<sup>th</sup> September' 2025 and the information had to be provided to the Appellant on or before 9<sup>th</sup> October' 2025 as per Section 7(1) of RTI, Act 2005.

And whereas, the PIO-cum-Executive Engineer, RWD, Daporijo Division, Upper Subansiri District, disobedience to the duly issued directives of the Arunachal Pradesh

Information Commission (APIC) undermines the authority of the Commission and hinders the transparent flow of information(s) as mandated by the RTI, Act, 2005.

Therefore, it is hereby directed that the Secretary RWD, Govt. of Arunachal Pradesh, to initiate appropriate disciplinary action against the PIO-cum-Executive Engineer, RWD, Daporijo Division, Upper Subansiri District, for his failure to comply with the Commission's order of **09.09.2025** and to submit the copy of the action taken report to the Arunachal Pradesh Information Commission (APIC) without fail.


It is further ordered that the report on the action taken in this regard be submitted to this Commission within 30 days from the date of this order.

**JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant Shri Niyae Lingri on **30/01/2024** filed an RTI application in Form- 'A' before the PIO-cum-Executive Engineer, RWD, Daporijo, Upper Subansiri District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application; The Appellant not being provided with the information by the PIO, filed the First Appeal before the First Appellate Authority (FAA) on **01/03/2024**. Appellant again having not received the required information from the FAA, filed the second Appeal before the Arunachal Pradesh Information Commission on **02/05/2024** and the Registry of the Commission (APIC) having receipt of the complaint registered it as **APIC- 196/2024 (Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for six (6) consecutive time on **18.06.2024, 30.07.2024, 26.11.2024, 04.02.2025, 08.04.2025 & 09.09.2025**. Details of information(s) sought from the PIO;

1. Provide certified copy of sanctioned orders, NIT advertisement, DPR, Participants of Firms (Bidders), and detail of Work Awardees Firm of C/o PMGSY Road from Chichi O-Point to Eso via Haring Kamsar & C/o PMGSY Road from Rakle to Liaye Nungnu via Tasiring, Reamuk, Kamda, Baring.
2. Provide certified copy of Work Order and Cheque/payment issued to contractor, Utility Certificate, Agreement with contractor, completion photographs, completion certificates, Geo-Gagged of construction site of C/o PMGSY Road from Rakle to Liaye Nungnu via Tasiring, Reamuk, Kamda, Baring.
3. Board proceeding reports and approval order from the competent authority.
4. Present status of the project including Physical and Financial Progress of the projects.
5. Re-estimate of cost or cost escalation of the projects if any.

In the sixth and final hearing of this instant appeal on 09.09.2025, the Appellant is present in person during the hearing before the Commission.

The PIO-cum-EE, RWD, Daporijo, Upper Subansiri District, Govt. of Arunachal Pradesh found absent for the sixth consecutive time even after the service of notice from the Commission for hearing on 18.06.2024, on 30.07.2024, on 12.08.2024 on 03.09.2024, on 04.02.2025, on 08.04.2025, on 08.04.2025 and on 09.09.2025 were served upon the PIO-cum-Executive Engineer, RWD, Daporijo.

Going through the Form-A of the Appellant it is seen that the Appellant has not applied for information(s) which are exempted under Sections 8 and 11 under RTI, Act, 2005.

6 (Six) chances of "being heard" have been given exhaustively to the PIO but the ill intention of the PIO in disobeying the orders of the Commission hereby portrays about the cunning ways of the PIO and denial of the information to the Appellant, **therefore, the Commission hereby observes:**

- i) The Appellant Shri Niaye Lingri has been present in the hearing of his appeal very seriously even after coming from very a far off area from Lingri Village which is 58 KM from the Daporijo Town, without fail to Itanagar.
- ii) The information(s) sought by the Appellant are in the public interest as he has applied for the information regarding construction of 2 (two) roads which the Appellant briefed the Commission that funds for the said 2 (two) road projects have been utilized already but in practical the roads have not been built and to unearth the reality of the whole thing he had applied for the information(s) in the welfare of villages that were to be benefited by this 2 (two) roads.
- iii) The claims of the Appellant, that the 2 (two) roads are constructed only on paper but not on the practical ground may be the reason why the PIO is unwilling to provide the information(s) to the Appellant as the PIO may not even have the minimum requisite documents to prove and provide to the Appellant.

**Under the above stated circumstances and the facts the Commission hereby order;**

- (i) To compensate the travel expenses of the Appellant, who has travelled under hardship from Lingri Village to Itanagar for the hearing of this appeal for all the 6(six) hearings and so, the Commission hereby orders the PIO-cum-Executive Engineer, RWD, Daporijo, Upper Subansiri District, Govt. of Arunachal Pradesh to pay an amount of Rs. 10,000/- (rupees ten thousand only) within one month from the date of this order to the Appellant. The compensation for travel expenses shall be deposited into the Bank Account of Shri Niaye Lingri, Bearing Bank Account No. 34843598928, SBI Nirjuli Branch, Arunachal Pradesh.
- (ii) To provide all the information(s) as applied by the Appellant completely within one month from today, failing which, strict action as provided under the RTI, Act, 2005 shall be initiated against the PIO.
- (iii) The Appellant to intimate the receipt or non receipt of the information(s) from the PIO within 30 days from today.



**Order;**

In view of the above facts and circumstance the Commission, find this appeal fit to be disposed and closed. And, accordingly, this Appeal stands disposed of.

Judgment pronounced in the open Court of this Commission today on this 9<sup>th</sup> day of September' 2025. Copy of Judgment be furnished to the parties.
