ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant Shri Honlem Khangam on **22/05/2023** filed an RTI application in Form- 'A' before the PIO-cum-DDSE, Longding, Longding District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application; The Appellant not being provided with the information by the PIO, filed the First Appeal before the First Appellate Authority (FAA) on **11/07/2023**. Appellant again having not received the required information from the FAA, filed the second Appeal before the Arunachal Pradesh Information Commission on **28/08/2023** and the Registry of the Commission (APIC) in receipt of the complaint registered it as **APIC- 828/2023 (Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **03.12.2024, 13.02.2025 & 03.07.2025**. detail of information(s) sought from the PIO;

Furnish the copies;

- (1) CTC list of Govt. schools (residential/middle/secondary/higher secondary) in Longding district in a category wise.
- (2) CTC list of private schools (middle/secondary/higher secondary) in Longding district in a category wise.
- (3) CTC list of Govt. employees (teaching staff) posted at different Govt. schools of Longding district in a category wise.
- (4) CTC of appointment/joining letter served from the appropriate authority in a category wise.
- (5) CTC of payment and the pay scale as per their designations in a category wise.
- (6) CTC of contractual, contingency (if any) and regular Govt. employees (teaching staff) list in a category wise.\
- (7) CTC of the designations of PRT (Primary teacher), TGT (Trained Graduate Teacher), PGT (Post Graduate Teacher) with their names, designations and current posting place in various Government schools of Longding district in a category wise.

The Commission observes;

The Appellant Shri Hondem Khangam found absent for consecutive three hearings on **03.12.2024, 13.02.2025 and 03.07.2025**. In all the hearings the Commission has issued notices to the Appellant to attend the hearing without fail and that the

Commission clearly instructed that on the failure of the Appellant in the next hearing this instant appeal will be decided Ex-parte.

In the final hearing of the appeal **03.07.2025** both the parties are absent without intimating the Commission the reason for their inability to attend the hearing before the Commission.

And therefore, the Commission hereby orders;

1. The Appellant is not being serious on the appeal and is repeatedly wasting the precious time of the Commission as well as unnecessarily wasting the public resources incurred in sending notices to him. And therefore, this appeal is dismissed Ex-parte.

Order;

In view of the above facts and circumstance the Commission, finds this appeal fit to be dismissed and closed. And, accordingly, this Appeal stands dismissed ex-parte and closed once for all.


