Information sought :

The appellant file a RTI Application dated 09/12/2022 seeking Details regarding works implemented from 2018 to 2022 under PWD Sub-Division, Sangram Division, Kurung Kumey District.

As per the case record, PIO did not provide the sought information.

Being dissatisfied, the appellant filed First Appeal dated 20/01/2023. No hearing was conducted by the First Appellate Authority in his jurisdiction. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Riya Taram absent.
Respondent : PIO-cum-EE(PWD), Sangram Division present in person.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Riya Taram on **09/12/2022** filed an RTI application under Form-‘A’ before the PIO-cum-Executive Engineer (PWD), Sangram Division, Kurung Kumey District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **20.01.2023**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **22/02/2023** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 143/2023**, and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for twelve time i.e on 30/06/2023, 01/09/2023, 03/11/2023, 22/12/2023, 12/04/2024, 17/05/2024, 10/03/2025 06/08/2025, 01/09/2025, 03/11/2025, 11/03/2025 and 04/05/2026. In this hearing of the appeal on 4th day of May, 2026, PIO-cum-EE(PWD), Sangram Division present in person but the appellant Shri Riya Taram found absent, however, he sent a request letter to dispose of the appeal case No. APIC-143/2023.

Request accepted and the appeal case No. APIC-143/2023 is disposed of and closed.
