Information sought :

The appellant file an RTI Application dated 11/11/2024 seeking Details regarding – C/o the total list of project sanctioned under PMJVK, erstwhile-MsDP scheme.

As per the case record, PIO has never conducted the hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 27/12/2024. No hearing has been conducted by the First Appellate Authority. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Tamchi Gungte on 27/12/2024 filed an RTL application under Form- 'A' before the PIO-cum-Executive Engineer, Dept. of WRD Division Deomali, District:-Tirap, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 27/12/2024, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 17/07/2025 and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No-171/2025(Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for first time i.e on 17/07/2025. In this hearing of the appeal on 8th day of September, 2025, the appellant Shri Tamchi Gungte present and the PIO-cum-Executive Engineer Dept. of WRD, Division Deomali, Tirap District present. However, a request made today from the appellant Shri Tamchi Gungte to dispose the case as he has received all the information and does not want to pursue the case any more.

Request is accepted and the appeal case No APIC-171/2025(Appeal) disposed and closed.

Judgment/Order pronounced in the open Court of this Commission today on this 8th day of September, 2025. Each copy of Judgment/Order be furnished to the parties.


