**JUDGEMENT**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Tania June on 02/06/2025 filed an RTI application under Form-'A' before the PIO-Cum-Under Secretary (Health) Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 18/07/2025, the Appellant again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 19/08/2025 and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No-633/2025(Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 1<sup>st</sup> hearing on 25/11/2025 .
