**JUDGEMENT ORDER**

This is an appeal under section 19(3) of RTI Act, 2005 was received from **Shri Tarh Olik, G-Extension, Ward no. 16, Near Techii Takar Community Hall, PO/PS-Naharlagun, Arunachal Pradesh**, for non-furnishing of information, by the **PIO –cum-EE, IMC Itanagar Subdivision, Govt. of Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 26.06.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

**“Itanagar Municipal Corporation (IMC) Sanitation Vehicle for the period 2021 to 2022.”**

The above subject has been mentioned in detail under 'Form – A'.

The 1<sup>st</sup> hearing of this case was held on the 26<sup>th</sup> day of October'2022. The appellant was present but the PIO was absent. Hence, the case couldn't be heard. Therefore, Court/Commission has fixed the next date of hearing of this case on the 16<sup>th</sup> day of Nov'2023.

The 2<sup>nd</sup> hearing of this case was held on the 16<sup>th</sup> day of Nov'2023. Both the parties were present. After hearing both the parties, the concerned PIO of IMC was served with hearing notice to appear this case which had been fixed on the 7<sup>th</sup> day of December'2022.

The 3<sup>rd</sup> hearing of this hearing was held on the 23<sup>rd</sup> day of December'2022. The representative of the appellant, Advocate Octu Mangam was present. The representative of the PIO, Mr. B. Kawa (APIO) was also present. After hearing both the parties, the representative of the PIO stated that he would inform the PIO and all the information sought by the appellant would be furnished on or before the next date of hearing of this case fixed on the 18<sup>th</sup> day of January'2023.

The 4<sup>th</sup> hearing of this case was held on the 18<sup>th</sup> day of January'2023. Appellant was absent but the PIO was present. Information sought by the appellant was brought by the PIO during the hearing of this case. The representative of the appellant, Advocate Octu Mangam reached the Court lately owing to some technical snaps of his vehicle and received the information furnished by the PIO. The Court directed the representative of the appellant to go through the same and inform his satisfaction/dissatisfaction on or before the next date of hearing of this case fixed on the 08<sup>th</sup> day of Feb'2023.

On the 23<sup>rd</sup> day of January'2023, the appellant sent a letter through WhatsApp (copy enclosed for ready references) stating that he has received all the information as sought by him and was fully satisfied with the information furnished by the PIO and pleaded for the disposal of the case. Hence, the case is disposed of.

*Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.*
