JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI 2005. Brief fact of the case is that the Appellant Shri Dawa Tsering on **16/11/2023** filed an RTI application in Form- 'A' before the PIO-cum-Executive Engineer, RWD, Dirang Division, West Kameng District, Govt. of Arunachal Pradesh. Whereby seeking various information as quoted in Form 'A' application; The Appellant not being provided with the information by the PIO, filed the First Appeal before the First Appellate Authority (FAA) on **03/01/2024**. Appellant again having not received the required information from the FAA, filed the second Appeal before the Arunachal Pradesh Information Commission on **30/04/2024** and the Registry of the Commission (APIC) having receipt of the complaint registered it as **APIC- 193/2024 (Appeal)** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on **18.06.2024, 30.07.2024, 26.11.2024 & 01.07.2025**. details of information(s) sought from the PIO;

- 1) Furnish the name list of all the works along with sanction amount under RWD Dirang Division since 2018 till date.
- 2) Furnish physical and financial status/progress of all the works sanctioned under RWD Dirang Division since 2018 to till date.
- 3) Furnish complete name list and amount sanctioned for PMGSY roads and bridges constructed under RWD Dirang division since inception.
- 4) Furnish five years maintenance funds sanctioned against all the PMGSY roads under RWD Dirang Division since inception.
- 5) Furnish details of separate funds sanctioned for repair and maintenance of PMGSY roads and bridges under RWD Dirang Division.
- 6) Furnish names of the contractors and firms responsible for execution of all the works under RWD Dirang Division since 2018 to till date.

In the final hearing the Appellant present in person before the Commission. The PIO present through online mode before the Commission.

After hearing both the parties and going through the previous judgment/order pronounced by the Commission: **the Commission hereby pronounce follows;**

- i) This matter has already been decided on 26.11.2024.
- ii) There is no need of the PIO to certify each and every page of information(s) as true copy, a covering letter certified by the PIO to the effect that the information(s) provided are true copy and authentic document is more than enough to certifying that the set of information(s) are official documents.
- iii) The prayer of the Appellant to initiate disciplinary action against the PIO is rejected for the fact that the judgment by the Commission on 26.11.2024 has been pronounced in accordance in the wisdom of the Commission as well as according to the procedural law of RTI, Act, 2005.
- iv) Be that as it may the Appellant is given liberty to file fresh application for the same set of information, if he needs so.

Order;

In view of the above facts and circumstance the Commission, finds this appeal fit to be disposed and closed. And, accordingly, this Appeal stands disposed and closed once for all.


