ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tamchi Gungte, Near KV2 School, Chimpu, Itanagar, Arunachal Pradesh, for non-furnishing of information by the PIO-cum- EE(PWD), Deptt. of PWD, Mariyang Division, PO/PS Mariyang, Upper Siang District, Arunachal Pradesh, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A dated 09/10/2024 regarding Construction of Road from PWD Road to Pekimodi in Upper Siang District (22.11km) under North East Special Infrastructure Development Schemes(Road) during the financial year 2024-25.
- 2). The 3rd hearing was held on 9th September' 2025. Shri Bom Borang, the PIO-cum- EE(PWD), Deptt. of PWD, Mariyang Division, PO/PS Mariyang, Upper Siang District, Arunachal Pradesh was represented by Shri Taying Sitang, the APIO –cum-AE (PWD), Deptt. of PWD, Mariyang Division. The Appellant Shri Tamchi Gungte was present.
- 3). The Appellant informed the Commission that the PIO had furnished information but information furnished against **Sl. no. 2** (the documents submitted for Technical Bid, like Financial stability, insolvency etc) , and **Sl.no. 11** (Experience certificate) were incomplete. Also, website link provided against the **Sl.no. 9**, (Newspaper in which NIT was published) was not accessible.
- 4). The APIO responded that all the available information for the Sl.no. 2 had been furnished. That the information sought at Sl.no. 11 were not available, as the provision was not stipulated in the tender and that the link provided against the Sl.no. 9 was accessible.
- 5). The Commission after hearing both the parties directed the Appellant to work out the specific information that he required against the Sl.no. 2 and get the information from the PIO. The Appellant was also asked to be satisfied with the reply given against the Sl.no. 11, as the reasons for non availability had been provided by the PIO under his signature.

6). The Commission directed the APIO to furnish screen shot of e-tender as sought at sl.no. 9, and furnish information for Sl.no. 2 as specified by the Appellant. The information had to be furnished to the Appellant within fifteen days from the date of issue of the order dated 9th September'2025. The Appellant was also asked to collect information from the office of the PIO and intimate the Commission in writing, his satisfaction or dissatisfaction and cautioned that in case he failed to intimate to the Commission within ten days from the expiry of above time given to the PIO, the case would be disposed of.

7). Till date the Appellant has not given any intimation to the Commission and therefore, in view of the order dated 9th September'2025 the Commission decides to dispose of the case.

8). Therefore, the case is hereby disposed of.
