#### ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Kumar Tayam, Jami-Jatte, 6-Kilo, Po/PS Itanagar Papumpare District, Arunachal Pradesh, for non-furnishing of information by the Public Information Officer, O/o Secretary Printing & Stationary, Govt. of Arunachal Pradesh, Civil Secretariat, Itanagar, as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 11/03/2025 regarding Director, Joint Director, Dy. Director, Assistant Director, Group-B & C.
- 2). The 2<sup>nd</sup> hearing was held on 11<sup>th</sup> November' 2025 (Tuesday) at 1100 hrs. The PIO-Cum-Director of Printing & Stationery, Govt. of Arunachal Pradesh, and the Appellant Shri Kumar Tayam were absent.
- 3). The Appellant submitted a letter Vide no Nil. Dated 19/09/2025 addressed to the Commission that the information so furnished by the Director Printing & Stationery was incomplete. Hence, he was dissatisfied with the information.
- 4). Shri Heri Maring, PIO- Cum- Director of Printing & Stationery, Govt. of Arunachal Pradesh vide No. DoP (Estt)-111/2019/509 Dated Naharlagun, 7<sup>th</sup> November' 2025 stated that the information as sought by the Appellant Shri Kumar Tayum has been furnished and was personally received by him vide letter No. DoP (Estt)-111/2019-424 Dated 17<sup>th</sup> September 2025. Further, the PIO requested for disposing of the case.
- 5). The Appellant was found absent in today's hearing and no representative was present on his behalf. Therefore, it is presumed that the Appellant was satisfied with the information so furnished by the PIO. However, the requisite information may be provided by the PIO, if approached by the Appellant.

Based on the input provided by the PIO-Cum- Director, Printing and Stationery, Naharlagun, the Commission finds it fit to dispose of the case.

Therefore, the case is hereby disposed.
