Information sought :

The appellant file an RTI Application dated 23/10/2024 seeking Details regarding construction of double line road to provide Airport connectivity from Donyi Polo Airport from Itanagar to Naharlagun.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellant filed First Appeal dated 27/12/2024. No hearing has been conducted by the First Appellate in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

The following were present.

Appellant : Shri Gollo Hade and Gollo Raja absent.

Respondent : PIO-cum-EE (PWD), Naharlagun Division absent.

JUDGMENT/ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Gollo Hade and Gollo Raja on **23.10.2024** filed an RTI application under Form-'A' before the PIO-Cum- Executive Engineer (PWD), Naharlagun Division, Papum Pare District, Govt. of Arunachal Pradesh whereby, seeking

various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **27.12.2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **07.01.2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 284/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for two time i.e on 10/09/2025 and 10/11/2025. In this hearing of the appeal on 10th day of November, 2025, PIO-cum-EE (PWD), Naharlagun Division and the appellants Shri Gollo Hade and Gollo Raja found absent without any intimation to the Commission.

On the last hearing the PIO was present through VC but the appellant was absent without any intimation. PIO has stated before the Commission that he tried to contact with the appellant for last four months to intimate them to collect the documents from the office of the PIO as said documents were ready to be furnished.

The Commission has directed the appellant to contact the PIO and collect the information from the office of the PIO and also appellant was directed to intimate to the Commission after getting the information from the PIO.

The appellant were cautioned that if no intimation is made, the Commission will presume that the appellants have collected the information and satisfied.

Today the appellants are found absent without any intimation inspite of giving sufficient time to collect the information. The Commission presumes that the appellants are no more interested to pursue this appeal case. Therefore, this appeal case No. 284/A/2025 is disposed of and closed.
