JUDGEMENT ORDER

This is an appeal under section 19(3) of RTI Act, 2005 was received from Shri **Tania June C/o Post Office, Naharlagun, Arunachal Pradesh**, for non-furnishing of information, by **PIO –cum- EE PWD, Naharlagun Division, Arunachal Pradesh**, as sought for by the appellant under section 6(1) of RTI Act, 2005.

Brief fact of the case being that the appellant on 29.06.2022 filed an RTI application under 'Form-A' before the PIO, whereby, seeking various information regarding:

***"C/o Retaining Wall at Abotani Village Karsingsa(Dry Nallah Upper) under DC Capital UntiedFund for the year 2021-22"***.

The above subject has been mentioned in detail under 'Form – A'.

The 1<sup>st</sup> hearing of this case was held on 23.11.2022. The appellant was present and Shri Pema Dorjee Kochi, AE, PWD Naharlagun Subdivision No-IV represented on behalf of the PIO. All the information as sought by the appellant has been provided by the representative of the PIO during the hearing of this case and the appellant has been directed to go through the same and should inform his satisfaction/dissatisfaction on or before the next date of hearing of this case fixed on 21.12.2022

The 2<sup>nd</sup> hearing of this case was held on 21.12.2022. The appellant and the representative of the PIO was present. The appellant informed the Court that the information as sought by him has already been provided by the representative of the PIO during its previous hearing and after going through the same he is fully satisfied with the information and pleaded for disposal of the case.

**Considering all the above aspects into account, I find this appeal fit to be disposed of as infructuous. And, accordingly, this appeal stands disposed of and closed for once and for all. Each copy of this order disposing the appeal is furnished to the parties.**
