Information sought :

The appellant file a RTI Application dated 06/05/2025 seeking Details regarding Infrastructure development for Kodum Circle HQ i/c C/o staff quarters and boundary wall in West Siang District.

As per the case record, PIO did not furnish the sought information.

Being dissatisfied, the appellants filed First Appeal dated 17/06/2025. First Appellate Authority was conducted hearing in his jurisdiction on 26/08/2025. Feeling aggrieved and dissatisfied by the order of the FAA, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Shri Hemmar Diyum on **06/05/2025** filed an RTI application under Form-'A' before the PIO-cum-EE (PWD), Aalo Division, West Siang District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **17/06/2025**, Appellants, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **01/09/2025** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 665/A/2025** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 3 times i.e on 09/02/2026, 18/05/2026 and 03/08/2026. In this hearing of the appeal on **3rd day of August, 2026**, PIO-cum-EE (PWD), Aalo Division present through VC but the appellants Shri Hemmar Diyum found absent, however, he sent a letter addressed to the Commission requesting to dispose of the appeal case.

Request accepted and the appeal case is disposed of and closed.
