**JUDGMENT/ORDER**

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Tania June on 24.01.2023 filed an RTI application under Form-'A' before the PIO-Cum-EE, Power Division, Likabali, Lower Siang District, Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on 29.03.2023, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 15.05.2023 and the Registry of the Commission (APIC), having receipt of the Complaint, registered it as **APIC No. 457/2023** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for 3 (three) times i.e on 26.06.2023, 14.08.2023 & 04.09.2023. In this hearing of the appeal on 4<sup>th</sup> day of October,2023. Both the parties present during the hearing.

During the hearing, the PIO furnished the information to the appellant as sought by him in the Form-' A' application.

Accordingly, the appellant after received of the information and immediately he gone through the information and intimated to the Commission that he is satisfied with the information which furnished by the PIO and requested for disposal/closer of his appellant on the ground of satisfactorily receipt of all the information sought from the PIO.

In view of the above facts and circumstances, I find this appeal fit to be disposed of and closed. And, accordingly, this appeal stands disposed of and closed for once for all.
