Information sought :

The appellant file a RTI Application dated 07/09/2024 seeking Details regarding (i) Integrated large scale Eri Farming Project under NERTPS etc. at East Siang District.

As per the case record, PIO has never conducted hearing under his jurisdiction.

Being dissatisfied, the appellant filed First Appeal dated 01/11/2024. No hearing has been conducted by the First Appellate Authority in this regard. Feeling aggrieved and dissatisfied, appellant approached the Commission with instant Second Appeal.

JUDGEMENT ORDER

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellants Miss Bengia Mamu on **07.09.2024** filed an RTI application under Form-'A' before the PIO-cum-Assistant Director, Textile & Handicraft, Pasighat, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not satisfied with the information received from the PIO, filed the First Appeal before the First Appellate Authority on **01.11.2024**, Appellant, again having not received the required information from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on **01.12.2024** and the Registry of the Commission (APIC), having receipt of the appeal, registered it as **APIC No. 418/2024** and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission for one time i.e on 07/07/2025. In this hearing of the appeal on 7th day of July, 2025, both the parties, PIOcum-Asstt. Director, Textile & Handicraft, Pasighat and Miss Bengia Mama found absent. However, the appellant Miss Bengia Mama sent a letter requesting to dispose off the appeal case No. APIC-418/2024 as all the information sought has been received from the PIO and she is satisfied with the information provided.

Request accepted and the appeal case No. APIC-418/2024 is disposed off and closed.
