JUDGEMENT

This is an appeal filed under sub-section (3) of Section 19 of the RTI Act, 2005. Brief fact of the case is that the Appellant Shri Tamchi Gungte on 15/01/2025 filed an RTI application under Form-'A' before the PIO-Cum- DFO Khellong Forest Division Department of Environment & Climate Change West Kameng District, Govt. of Arunachal Pradesh whereby, seeking various information, as quoted in Form-A application. The Appellant, being not receiving the information from the PIO, filed the First Appeal before the First Appellate Authority on 27/11/2024, the Appellant again having not received the required information(s) from the FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 5/12/2024 and the Registry of the Commission (APIC), having receipt of the Appeal registered it as APIC No-79/2025(Appeal) and processed the same for its hearing and disposal.

Accordingly, matter came up for hearing before the Commission on 6/5/2025, 31/7/2025 & 11//11/2025.

Details of information sought by the Appellant.

C/o "Creation of CA Plantation in the Construction of 2880 MW Dibang Multipurpose Projects by NHPC

- 1. Furnish the Certified copy of total area created for CA plantation along with geotag and MIS report of the area.
- 2. Furnish the certified copy of total nos. of Raised seeding casualty/replacement, along with proper names and photos (glossy paper in color) of the plants.
- 3. Furnish the certified name of Nursery where the seedlings is raised for replacement with photocopy (color).
- 4. Furnish the certified copy of total length of fireline cutting along with geotag and MIS report along with photocopy.
- 5. Furnish the certified Photocopy of Inspection Path along with geotag and MIS report.
- 6. Furnish the certified copy of total area of weeding along with photocopy and MIS report.
- 7. Furnish the certified copy of total nos. of Plantation Watcher along with their Identity card or Adhaar card copy.
- 8. Furnish the certified amounts of wages of the one Plantation Watcher in a month.
- Furnish the certified copy of payment of wages made to the Plantation Watcher along with Bank transaction details of all the transaction made by the Division to the Plantation Watcher.
- 10. Furnish the certified copy of total nos. of Plantation Supervisor along with their Identity card or Adhaar card copy.
- 11. Furnish the certified amounts of wages of the one Plantation Supervisor in a month.
- 12. Furnish the certified copy of payment of wages made to the Plantation Supervisor along with Bank transaction details of all the transaction made by the Division to the Plantation Supervisor.
- 13. Furnish the certified copy of total nos, and total length of the fencing constructed by the division, along with Photocopy, Geo Tag and MIS report.
- 14. Furnished the certified copy of Utilisation Certificates of the projects sanctioned.

15. Furnish the certified LOC Copy of the subject mention above.

16. Furnished the certified Photograph of all Works (coloured photo) before starting of work and after completion of work.
