ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Lokam Namdu for non-furnishing of below mentioned information by the PIO, o/o the (DFO), Pasighat Forest Division, East Siang District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 20.06.2025:

A) Particular of information: seeking the details information regarding execution of work amounting to Rs. 216.76734 Lakhs for implementation of the item under "CA & NPV" component of state CAMPA AOP Vol-I during 2024-25.

B) Details of information required:

1. Total no. of CA issues with their amount details to all RFO.
2. Technical sanction order, DPR copy.
3. Furnish the NIT/NIQ details with News Paper Cutting.
4. Details of Contractor/Agency.
5. Work Order.
6. Measurement Block details.
7. Geo-Tag details photography of project site, GPS Map Camera copy.
8. Cheque counterfoils, billing transaction details or PFMS details.
9. First & Final Bill Statement/Abstract.
10. Furnish the DFO shall ensure that the proposed activities are being taken up after due consultation with Gram Sabha and are as per provision of FRA 2006, the activities proposed in Forest area are in consonance with approved working plan and activities proposed in protected areas (Pas) are in consonance with approved management plan. certificate in these regard may be submitted to State Authority CAMPA. A
11. Item-wise expenditure Rs. 216.76734 lakhs.
12. Furnish the name of Trees planted from last 4 (Four) years and location with GPS Map Camera during tree plantation activities,
13. Furnish the 10 (Ten) numbers casual engagement or labours to assist regular staff for protection of forest and WL for 12 (Twelve) months. Details names and designation, ID Proof like Aadhaar Card, Bank Passbook, ST, PRC, documents.
14. Furnish the 9 (Nine) numbers Plantation watchers, engagement order, name and designation, ID proof like Aadhaar Card, Bank Passbook, ST, PRC documents.

C) Furnish the specific details of items mentioned/ Certified true copy:

- a. Name of beneficiaries, firm, contractor with details address, specific location, contact numbers and contact details of the furnished beneficiaries, contract firm/agency.
- b. Mode and details of payment with specific date and year against the beneficiaries, firm, contract firm/agency with amount in figure in each.
- c. Voucher details and money receipt of payment made to each beneficiary, firm, contractor of furnished beneficiaries, contract firm/agency.

- d. Beneficiaries Identity Proof like- Aadhar Card, Voter ID with Contact Number.
- e. Furnish the beneficiaries signatures during cheque/cash received.
- f. Site inspection of work/verification.
- g. Bill voucher/challan submitted to AG Itanagar.
- h. Bank passbook use for transaction/name of account holder/account number and cheque number with amount details.

Brief facts emerging from the appeal and decision thereon:

Records disclose that the information as requested by the appellant remained unfurnished despite the appellant's appeal to the 1st Appellate Authority, the Chief Conservator of Forest (CCF) Western Arunachal Circle, Banderdewa, vide his Memo of appeal dt.31.07.2025. Hence, this Second appeal before the Commission which was filed on 06.10.2025.

This appeal is, accordingly, listed for hearing in this Commission today on 06.02.2026 but none of the parties appeared without any intimation which has been taken very seriously, particularly, that of the appellant's absence despite notice dt.08.01.2026 which was received by him on 09.01.2026 through whatsapp.

In the premises as above, this appeal stands closed in terms of the stipulation as contained in the Summon notice that in default of the parties non-appearance on the date listed for hearing, the case shall be determined in their absence.
